GHCFRW General Meeting Minutes - November 17, 2015

The November 17, 2015 general meeting of the Greater Houston Council of Federated Republican Women was held at the SOSA Center and called to order by President Barbara Tague. Due to the bad weather and heavy rain, the meeting began at 10:10am.

Chaplain Sophia Mafrige led the assembly in prayer and in the recitation of the pledges.

The elected officials and candidates were recognized and welcomed.

Jeannie Koenig, serving in the absence of Recording Secretary Alice Melancon, called roll and reported that a quorum was present. There were no corrections to the Minutes from the September 15, 2015 meeting.

Cindy Siegel provided copies of the Balance Sheet, ending October 31, 2015 electronically and in print. She reported that a billing error by Fratelli's Ristorante returned \$510 to our account. The report was accepted without further discussion.

- Edie Holland and Givvie Searcy thanked member RWs who provided refreshments during 2015 and invited members to volunteer to provide refreshments for the 2016 meetings.
- Cheryl Dalton asked members to continue to share ideas for speakers so they can be added to our Speaker Bureau List.
- Sherry Petersen noted that Theresa Kosmoski, Julie Faubel, and Cindy Siegel had all been chosen for leadership positions in the TFRW.
