My husband and I have been amazed by the amount of campaign literature swamping our mailbox every day. For the average voter without the knowledge that the Republican women of our clubs have – it must be difficult to determine what to believe about a particular candidate.  \checkmark How does this compare to running a tough campaign? Again, in my opinion- tough campaigning is attacking the opposition based upon facts. What is the opposition's experience - both for the job and with the Republican Party? Have they voted regularly in Republican primaries? Have they actually voted? Have they supported other Republican candidates and the Republican Party? What are their qualifications for the office they're running for? How are they a better candidate than their opponent? What positions on \checkmark issues pertinent to the office or Republican Party has the candidate taken compared to their opponent that voters should be aware of? Tough campaigning is not shying away from presenting a clear distinction between two candidates based upon their experience, their support of the Republican Party, and their positions on various critical issues to the Republican voter. It is working hard to win and winning with integrity - not winning based upon personal attacks and misleading information.

As president of Greater Houston Council, like our club presidents, I am not allowed to endorse or support one Republican candidate in a race against another Republican candidate. But that does not mean that I can't stand up as a Republican woman and say, "I will not vote for a Republican candidate who runs a cam- $\overset{\frown}{\Sigma}$ paign based upon "fake news" and smear tactics." 

Legislative Report by Wendi Lojo

Texas Commission on Public School Finance

In response to a legal challenge to our school finance system, the Texas Supreme Court ruled in 2014 that while the system met "minimal constitutional requirements," Texas school children deserve an updated, revamped system. The Supreme Court issued an "urgent challenge" to legislators "to fashion a school system fit for our dynamic and fast-growing State's unique characteristics."

The legislature's attempts at school finance reform since the 2014 Supreme Court opinion have unfortunately failed as no consensus between the House and the Senate could be reached on how to best overhaul the system. Ultimately, both chambers agreed to establish the Texas Commission on Public School Finance to study and make recommendations for improvements to the public school finance system or develop new methods for financing public schools. The commission shall prepare and issue a report no later than December 31, 2018. The Commission is tasked with developing recommendations to address issues including:

1. the purpose of the public school finance system and the relationship between state and local funding in that system;

2. the appropriate levels of local maintenance and operations and interest and sinking fund tax effort necessary to implement a public school finance system that complies with the requirements under the Texas Constitution; and

3. policy changes to the public school finance system necessary to adjust for student demographics and the geographic diversity in the state.

The Governor, Lt. Governor, Speaker of the House and State Board of Education all appointed members to the commission. The Commission members are:

• Justice Scott Brister (Commission Chair), Georgetown – Former Justice of the Supreme Court of Texas (Appointed by the Governor)

• Rep. Diego Bernal, San Antonio – Vice Chair of the House Committee on Public Education (Appointed by the Speaker)

• Sen. Paul Bettencourt, Houston – Member of the Senate Committee on Education (Appointed by the Lt. Governor)

• Dr. Keven Ellis, Lufkin – State Board of Education Member, District 9 (Appointed by the State Board of Education)

• Rep. Dan Huberty, Houston – Chair of the House Committee on Public Education (Appointed by the Speaker)

• Nicole Conley Johnson, Austin – Austin Independent School District Chief Financial Officer (Appointed by the Speaker)

• Rep. Ken King, Canadian – Member of the House Committee on Public Education (Appointed by the Speaker)

• Dr. Doug Killian, Pflugerville – Pflugerville Independent School District Superintendent (Appointed by the Lt. Governor)

• Melissa Martin, Deer Park – Galena Park Independent School District Career and Technology Teacher (Appointed by the Governor)

• Rep. Elvira Reyna, Denton County – Former State Representative for District 101 (Appointed by the Governor)

• Sen. Larry Taylor, Friendswood – Chair of the Senate Committee on Education (Appointed by the Lt. Governor)

• Sen. Royce West, Dallas – Member of the Senate Committee on Education (Appointed by the Lt. Governor)

• Todd Williams, Dallas – The Commit Partnership founding Chairman and Executive Director (Appointed by the Governor)

Most lawmakers and elected officials remain hopeful that after a thorough study of the school finance system, the Commission will issue proposals to reconstruct effective, equitable reforms to help increase funding to public schools. All are working to stop the repeated legal challenges to the system and meet the ultimate goal of providing the best "efficient system of public free schools" as constitutionally required.

You can be a delegate to the Republican State Convention!

What is the Republican State Convention?

It's a place for people who vote in the Republican Primary election to define our shared beliefs and to determine how we will promote them. We do this by creating a platform and by setting rules and electing people to run the party between conventions.

Who can attend the Republican State Convention?

Anyone who is a registered voter, who has affiliated with the Republican Party, either by voting in the Party Primary or by taking an oath of affiliation, and has been duly elected by the lower level conventions. You can affiliate with the Republican Party by voting in the Republican Primary Election or by taking an oath of affiliation. You can only affiliate with one party during each election year.

What is a delegate?

Delegates are grassroots Republicans who participate in the shaping of the Republican Party, its role, and its direction regarding public policy. They volunteer and are chosen by their districts to attend the party's conventions in each even-numbered year.

Step 1: Precinct Conventions

<u>When and where:</u> Your 2018 Precinct Convention will be held sometime *after* the polls close on Primary Election Day (March 6, 2018) and *before* the start of the County/Senate District Conventions (March 24, 2018). Please check with your local Republican County Chair for the most up to date information. (See <u>https://www.texasgop.org/county_chairs/</u>)

What to expect: If you are a registered voter and affiliate with the Republican Party, you can participate in this convention. You can introduce and vote on resolutions. Then elect delegates and alternates to the next convention level.

Step 2: County / Senate District Conventions

When and where: Your County or SD Convention will be held on March 24, 2018. Your county party sets the location and time.

What to expect: In the days or weeks before the convention, you can visit committee meetings and let them know what issues are important to you. At the convention, you'll set the rules by which the convention will operate. You will be able to vote on resolutions the committees have worked on. Then you'll elect delegates and alternates to the state convention level.

Step 3: State Convention

<u>When and where</u>: This convention will be held in San Antonio from June 11th-16th. Committees will meet June 11th-13th. General Session and Caucuses will meet June 14th-16th. Please check <u>www.texaseop.org</u> for convention details.

<u>What to expect</u>: You will be able to testify before the committees on issues you care about, vote on the platform that will state the beliefs of the Party, vote on the rules that will steer the Party, and elect people to run the Party for the next two years.

Why become a delegate to the Republican State Convention?

Because you will have an instrumental role in shaping the beliefs of the Party and determining the methods of implementation in public policy.
