





# **RED DIALER UPDATE**

#### LEGISLATIVE REPORT

#### by SJ Swanson

We are currently in Texas' 86th Legislature Interim, with interim committees doing work per the charges of the Speaker of the House issued November 2019 https://house.texas.gov/\_media/pdf/interim-charges-86th.pdf, and Texas Senate stands adjourned sine die. In January 2021, Texas will enter the regular session of the 87th Legislature.

We are currently in the 116th U.S. Congress. The following is information from U.S. Congressman **Dan Crenshaw** of Texas' 2nd Congressional District.

#### PROTECTING OUR COMMUNITY FROM COVID-19

COVID-19 is having a severe impact on public health and our economy in Houston. But we can overcome this challenge together. I am in constant contact with hospitals and those on the front lines of this fight to make sure they have what they need to keep our communities safe and I'm encouraging Texans to take personal precautions to protect themselves and others from the pandemic.

I've distributed 50,000 masks to help people in our community do their part to prevent the spread. I also helped provide billions in federal resources to meet the needs of our health care workers, bolster the capacity of our health care system, and improve our testing capabilities. And I have repeatedly stepped in to extend federal support for COVID-19 testing in Houston.

I'll continue this work as we continue to fight this public health crisis. We are Houston Strong and we will get through this. (you can find updates and resources on the congressman's House website https://crenshaw.house.gov/coronavirus-resources/).

#### HOLDING PHARMACEUTICAL COMPANIES ACCOUNTABLE AND LOWERING DRUG PRICES

Americans pay too much for prescription drugs. That's why I helped introduce legislation (H.R. 19) along with other Republicans to hold pharmaceutical companies accountable, improve transparency, and lower your drug costs. My bill would stop pharmaceutical companies from engaging in unfair and uncompetitive behavior that raises your out-of-pocket costs at the pharmacy counter (https://congress.gov/bill/116th-congress/house-bill/19).

This plan also increases transparency in our health care system and protects your access to new drugs to ensure that America - not China - remains the world leader in medical innovation.

I'm also fighting back against dangerous policies like price controls in Congress like Nancy Pelosi's H.R. 3. One independent analysis of this bill found that it would lead to as many as 100 fewer life-saving drugs from coming to market because of the innovation lost as a result of this bill. That is unacceptable, especially as American innovators are working tirelessly to find a vaccine for COVID-19. We can lower drug prices without killing the medical innovation Americans rely upon.

#### PROTECTING PEOPLE WITH PRE-EXISTING CONDITIONS AND GIVING YOU CONTROL OF YOUR CARE

Americans living with pre-existing conditions should never be denied health care coverage. This is personal for me - my mom died of cancer when I was just 10 years old. That's why I'm supporting legislation in Congress that requires insurance companies to provide health care coverage to people with pre-existing conditions.

I also believe Americans should be in control of their health care, rather than being beholden to insurance companies or government regulation. That's why I'm working to expand direct primary care for Americans, which will allow greater flexibility and choice for patients while improving the doctor-to-patient relationship that we know is critical to quality of care.

I'll continue these efforts in Congress to fight for people with pre-existing conditions and make commonsense improvements to deliver higher-quality, affordable health care.

# **Greater Houston Council FRW Celebrates** the 100th Anniversary of Women's Right to Vote

Amendment XIX—The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any state on account of sex.



The Republican Party pioneered the right of women to vote and was consistent in its support throughout the long campaign for acceptance. It was the first major party to advocate equal rights for women and the principle of equal pay for equal work.

- ☆ Suffragists began their organized fight for women's right to vote in 1848. For 72 years, they marched, picketed and lobbied for the right to the ballot.
- 🕁 By a vote of 50-47, Tennessee became the last state needed to ratify the 19th Amendment on Aug. 18, 1920. A proclamation declared the 19th Amendment ratified and part of the US Constitution on Aug. 26, 1920.
- 100 years later, more than 68 million women vote in elections.
- ☆ The tri-colors, purple, white and gold, symbolizing loyalty, purity and life, was used exclusively by Congressional Union/ National Woman's Party.
- White and gold are the two colors historically used by the suffrage movement.
- Gold pins, ribbons and sashes, as well as yellow roses became symbols of the cause.
- Wearing white has become a visual symbol of solidarity for women.
- The yellow rose is the symbol of the women's suffrage movement.

On June 28, 1919, the Texas legislature voted to ratify the Nineteenth Amendment, the first southern state to do so. For more information on the Texas Women's Suffrage Movement go to the National Parks Service website: https://www.nps.gov/articles/ texas-women-s-history.htm



# The Presidential Election Can Be Changed

#### Without a Constitutional Amendment!



### From the National Republican Party Platform

"We oppose the **National Popular Vote Interstate Compact** and any other scheme to abolish or distort the procedures of the Electoral College. An unconstitutional effort to impose National Popular Vote would be a grave threat to our federal system and a guarantee of corruption, as every ballot box in every state would offer a chance to steal the presidency. We urge state legislatures that have voted for this proposal to rescind their approval."

What the heck is that?

The National Popular Vote Interstate Compact is an agreement among a group of U.S. states and the District of Columbia "to award all their respective electoral votes to whichever presidential candidate wins the overall popular vote in the 50 states and the District of Columbia." Wikipedia

Article Two, Section Two of the U. S. Constitution states:

Each State shall appoint, in such Manner as the Legislature thereof may direct, a Number of Electors, equal to the whole Number of Senators and Representatives to which the State may be entitled in the Congress: but no Senator or Representative, or Person holding an Office of Trust or Profit under the United States, shall be appointed an Elector.

The National Popular Vote Interstate Compact (NPVIC), when adopted by the State Legislature directs the Electors to cast Presidential and Vice-Presidential Votes per the national popular vote. In effect, this turns the Presidential Elections into a National Popularity contest. The candidates will then focus on the most populous states (think bright blue California and New York) rather than the entire country.

#### What is the Current Status of NPVIC?

Remembering that 270 Electoral Votes are needed, fifteen States and one Jurisdiction (Washington, DC) controlling 196 Electoral Votes have adopted NPVIC. Not surprisingly, these states are clustered on the East and West Coasts and Illinois. This means that only 74 Electoral Vote States are needed to turn the Presidential Election into a Popularity Contest.

#### What Can Republican Women Do?

Our National Committeewoman, *Toni Anne Dashiell*, presented our options at the November, 2018 meeting of the Greater Houston Council of Republican Women. During her eye-opening T.A.D. talk, these action items were suggested:

- 1: Educate your friends and family. If any live in the twelve states previously adopted NPVIC, request rescission of the Compact.
- 2. Pass resolutions and present them to elected officials.

Toni Anne Dashiell is fighting hard to defeat the NPVIC. Language mirroring the National Republican Party Platform should be inserted into the Texas State GOP Platform to support this effort.


(Publicizing your meetings and events, in-person and virtual)
