## Our History. Our Ancestors. Our Heritage.

The emergence of the Republican Party as the dominant political party in Texas took over a hundred years of work, a changed political environment, and a re-educated voting base. It was the result of a long, hard slog over decades that closely involved the GHCFRW and its predecessor organizations. That history, and the vision that helped change entrenched Texan voting patterns, provide valuable lessons for framing today's political climate and for going forward.

### Brief Background



Just as many people are surprised to learn that the Republican Party was founded as the antislavery party, people may be surprised to learn that the Republican Party of Texas was founded on July 4, 1867, by 150 black men and 20 Anglos in Houston Texas.

Dr. Tim Westley, Historian of the Republican Party of Texas, says that from the start, this "agrarian-based biracial nucleus intentionally reached out through the Freedmen's Bureau and other organizations to the newly freed and newly enfranchised freedmen to ensure they were registered to vote." In 155 years, technologies have changed but the goal --to register voters--has not.

That early Texas Republican effort to register voters is a direct ancestor to current TFRW and GHCFRW programs, including this year's Texas Republican Voter Engagement Project (TRVEP) which is attempting to register 100,000 new Republican voters.

#### The Foundation

Between 1867 and the middle of the 20th century

the GOP was a negligible factor in Texas politics.

In 1947 the Republican Club of Texas was founded by Captain J.F. Lucey of Dallas, called an "internationally prominent oilman and friend of Herbert Hoover" by the *New York Times*. However, it was not until 1952 that the current governing body of

the RPT, the State Republican Executive Committee, was organized.

The National Federation of Republican Women had been organized in 1938, however, it was not until 1955 that Republican women's clubs existed in three-quarters of Texas congressional districts, enabling the "federation" of the Texas Federation of Republican Women. For the discerning observer, the fact that by 1955 Republican women's clubs existed in so many congressional districts at a time when Texas was deep blue may have been seen as a harbinger of what was to come.

But there were other organizations. On their website, the Village Republican Women, which celebrated its 60th-anniversary last year, says that "at that time in Harris County (1955), only loosely structured precinct organizations (for women) existed.



"The purpose of those groups was to assist the precinct chairman with voter registration, identifying Republican voters,


and fundraising on behalf of the Party. The original name of our organization was the Precinct 273 Republican Women's Club (RWC) and our first President was Gerry Hardway."

## Our Heritage, cont'd.

It was not until 1961 that the club was officially chartered as a member of the TFRW. (The Braes Republican Women's Club was chartered in 1960 and is the oldest active TFRW club in Harris County.)

A year later, in June of 1962, the Harris County Council of Federated Republican Women was organized. Gerry Hardway, Village Republican Women, would be the first president of the Harris County Council of FRW.

That organization was later renamed the Greater Houston Council of Federated Republican Women to better reflect the growth and location of member clubs.



Although there were some early successes, such as the election of John Tower to the Senate in 1961, Texas would remain a deep blue state until the 1970s. However, the foundational organizations that would help drive change were in place.

## Brick-by-Brick

In 2008, the GHCFRW celebrated its 45<sup>th</sup> anniversary. Researchers prepared a timeline which was incorporated into a pamphlet distributed at the luncheon. (We've printed part of that pamphlet in this newsletter.) A close look at the activities of the GHCFRW suggests that its leaders and the leaders of its associated clubs clearly understood the necessity of a brick-by-brick approach to building a strong and vibrant GOP in Texas.

In 1963, the new organization and the Village Republican Women began a fundraising effort to register new voters. Apart from necessary organizational activities, such as developing and approving the bylaws, this was the first undertaking by what would be the GHCFRW.

By 1965, dollars were allocated to placing books in Houston public libraries to increase awareness of the Republican Party and its philosophy. Simultaneously, funds were raised through various activities – Red Garter parties, Pink Elephant balls, "Games" parties, and various teas – to support various candidates, including John Tower, the first Republican senator elected from Texas since Reconstruction.

From the start, the GHCFRW appears to have been purposeful about educating its members. Trips to Austin were organized. Speakers were solicited. By 2000, the *Nuts 'N Bolts* program had been created and presented to members. (In March 2013, *Nuts 'N Bolts* was mentioned by the Republican Party of Texas in its Resolution Honoring GHCFRW on the occasion of its 50<sup>th</sup> anniversary.)

Voter registration. Member and public education. Candidate support. These are the themes that run through every activity supported by the GHCFRW since its inception.

#### Blue-to-Red



GOP Party Historian Westley, among others, says that "Texas turned red in the late 70s and early 80s as a result of a population shift of Republican-leaning people who started

to populate the suburban (major) cities during the 70s and 80s. This trend included people relocating into Texas and many conservative Democrats shifting to the right and voting Republican."

Regardless of the motivations, what cannot be ignored is the fact that organizations, including the GHCFRW and its member clubs, were already on-the-ground providing the outreach and education that would help attract these voters to the GOP.

#### The Future

Westley issues a stark warning for the future. Today, he says, "the irony is that many Californians (who tend to be left-leaning Democrats) are

moving to Texas Metropolitan areas at a high rate. Cities in those areas have gone from Republican to Democrat and remain Democrat strongholds. The number of Californians moving to Texas has risen

over the past few years to the point that, according to the U.S. Census Bureau, almost 700,000 Californians have relocated to Texas since 2010."

The "2021 Texas Relocation Report" by the Texas Realtors says that more than 500,000 people moved to Texas in 2019 and it is the "seventh year in a row that Texas attracted more than 500,000 new residents." These numbers of course are pre-pandemic.

#### Conclusion

Back in 1867, the founders of the GOP in Texas conducted voter registration efforts in an atmosphere we can only imagine. Later, early GHCFRW voter registration efforts were conducted in a state that was so deep blue that GOP voter registration efforts might have been considered delusional. However, our GOP ancestors were undaunted.

If GHCFRW's history of 60 years proves anything, it is that the gains we see today are the product of a refusal to give up by those who believe in Republican principles. During the most dismal years of Democrat control of Texas, GHCFRW members continued to knock on doors, and hold bridge parties and coffees, among other efforts, to register Republican voters.

Today, in a far more benign and supportive environment, GHCFRW and TFRW leadership understand that new gains must be consolidated and built upon. It should also be noted that technology has made outreach swifter and easier than ever before. The Texas Republican Voter Engagement Project (TRVEP) is an example of a program in which most people can easily participate. And the women of GHCFRW clubs can take pride in the fact that these programs are direct descendants of those earliest voter registration efforts conducted so long ago and in such dark circumstances.

## A Look Back in Time

## Milestones from our Sapphire Anniversary

On Thursday, January 31, 2008, the Greater Houston Council of Federated Republican Women held its "Victory '08" Kick-Off Luncheon at the Intercontinental Hotel. The luncheon was also a celebration of the GHCFRW's 45<sup>th</sup> anniversary. Present at the luncheon was a "who's who" of Texas Republicans, including Judges, State Representatives, County Commissioners, and more.

As a part of that celebration, a 12-page pamphlet was printed, including sponsors, guests, and speakers. Researchers for the luncheon also prepared a meticulous timeline of GHCFRW milestones, a year-by-year review of activities and events dating from its 1962 founding. We can't reproduce the entire pamphlet; however, we've reproduced the cover page and the timeline below. Enjoy. (Use zoom button to enlarge.)

## History of Greater Houston Council of FRW

1962-1963 Republican Women's clubs in the Houston area first started as Precinct Clubs. The presidents of those clubs met at the request of TFRW to form what was then called Harris County Council of FRW. The first meeting was June 15, 1962, with bylaws approved on August 8. Gerry Hardway was the group's first president. She was also president of Village RW. In 1963, the group sold poll taxes in an attempt to register additional Republican voters and hosted the TFRW Convention in the fall at the Shamrock Hilton Hotel.

1964-1965 Mary Wright and Peggy Brelsford served as presidents and Pink Elephant Balls were held each year. The proceeds from the balls went to the campaign of John Tower and books were placed in public libraries to bring more awareness to the Republican Party and its philosophy.

1966-1967 Presidents were Eddie Nelezen Baker and Callie Robertson. More library books were donated and there was a Council Card Party at Battlestein's in Sharpstown. John Tower's campaign received \$150 as a result. There was a tea for Mrs. John Tower and over 300 attended. President Robertson donated a large U.S. flag to Council for permanent use upon leaving office.

1968-1969 Presidents began to serve two year terms and Jacquelyn Till was elected. The Nixon campaign was assisted by a fundraising dinner at the Shamrock, the first Council notebooks were assembled, and money was raised by selling poison antidote kits. On May 16, 1968, there were 4 teas for Mrs. John Tower and Mrs. Paul Eggers. Council later purchased a desk and folding chairs for Harris County RP Headquarters. Finally there were Republicans in the State Legislature – Bill Archer, Jim Earthman, Edmund Jones, and Will Lee in the House and Hank Grover in the Senate. Three bus-loads of members made a trip to Austin to see them in action.

1970-1971 Florence Neumeyer served as president and was active in Republican doings until her recent death. Under her direction, Council hosted Cleo Bohls, TFRW President, at a Lincoln Day luncheon and reception, held a Red Garter Party that netted \$191.52, held a tea for Art Bush, George Bush, Bill Archer, and John Tower, and was given a state flag flown over the Capitol by Sonny Jones. A "Games Party" and Luncheon in May, 1971 brought over \$400 to the treasury.

1972-1973 Carolyn Messenger was president and welcomed 3 new clubs - NW Harris County, Greater Tomball, and Ft. Bend. Also, Briargrove reactivated and Alief organized as well. Hank Grover received \$600 and a Membership Seminar was held. The group attended Legislative Day in Austin with the largest representation in the state – 77 riding buses to Austin. All 24 clubs helped host the TFRW Convention and Nancy Palm and Carolyn Messenger were named two of the 10 Outstanding RW at this time.

1974-1975 Barbara Cook served as President. Council held a tea to welcome Mrs. John Connally to the Republican Party. Also in attendance was Barbara Bush, wife of the Ambassador to Red China and Rita Bass, National Committeewoman. RW worked very hard to elect officials and for the first time at the county level, most especially Jon Lindsay, County Judge.

1976-1977 Ann Watson was elected president of Council and the group worked in the Congressional race for Dr. Ron Paul (CD 22). The Bicentennial of the U.S. was celebrated by attending a production of "1776" at Dunfey's Dinner Theater. There were 6 Republicans now serving in the Texas House – Milton Fox, Don Henderson, Chase Untermeyer, Bill Blythe, Frank Hartung and Brad Wright. Walter Mengden, Jr. served in the State Senate. Vera Carhart, Village RW, was elected President of TFRW.

1978-1979 Vicki Hapke was Council President and the first "No Lillies" Award was given to Village RW. Newsletters were regularly sent, legislative reports given, and dues were raised to \$15 per club. Eight new clubs joined, Lance Tarrance spoke about his polling firm, and a reception was held for Chet Upham, State Party Chairman, and his wife. The first Republican governor since Reconstruction was elected, Bill Clements. Christin Hartung was elected to City Council.

1980-1981 Peggy Englehart served as Council President and a "Peanut Stomp" t-shirt was sold to help bring defeat to Jimmy Carter by Ronald Reagan. Jack Fields was also elected to Congress in the 8th CD. In April, 1981, Council passed a resolution proposed by Carolyn Tarleton to be sent to the White House praying for the quick recovery of President Reagan and his press secretary, James Brady. Council members participated in Jon Lindsay's barbeque and speakers included DA Johnny Holmes and representatives from Joske's and Foley's discussing repeal of the Blue Law.

1982-1983 Penny Butler served as Madam President, and it was at this time that the name of the organization was changed to Greater Houston Council of FRW and there were 21 clubs included. Russ Mather, Harris County RP Chairman spoke and the proposed Houston Convention Center was debated by Alan Rudy and Jim McConn. Council donated \$25 for the purchase of an oil portrait of Ronald Reagan for Harris County RP Headquarters.

1984-1985 Rickey Thompson was elected president of our organization. There were four TFRW officers from the GHC area including Myrtis Gibson, Merle Carlson, Cindy Brockwell, and Marguerite Binkley.

1986-1987 Mary Karges was president and the new club presidents received Texas Sesquicentennial pins. Council sponsored a contest to get more participation in the precinct conventions, and Governor Bill Clements was re-elected. Council postponed its first meeting of the year so that members could attend his inauguration. While the U.S. Constitution celebrated its 200th birthday, Council celebrated its 25th anniversary and all former presidents received silver pins presented by Judge Jon Lindsay.

2000-2001 Mary Sergesketter was elected president at this time and two new offices were added to GHC leadership – Special Events and Ways & Means. An emphasis was placed on bringing young women into the political process with a special event, "Republican Women yesterday Today and Tomorrow." Focus groups were used to define our role for the future. "Nuts and Bolts" was organized by our TFRW deputy presidents and a special funcheon honoring Texas First Lady Anita Perry was held under the leadership of Deany Meinke, chairman. A record was set by the selling of "Bush" pins for the presidential election bringing in more than \$20,000 in profits. GHC sponsored two students from University of Houston to participate in the Bush Strike Force and also bought newspapers for students in underprivileged schools. Club members now numbered 41.

2002-2003 Peggy Mason was chosen to lead GHC. During her tenure, GHC began its website, our organization became a PAC as required by law, Republicars won by a landslide in November of 2002, and Republican Women began to greatly participate in the Dictionary Project as promoted by NFRW and TFRW. Some of the area clubs began to share ideas about outstanding projects they had in order to attract more members.

2004-2005 Sue Kikis was elected president of Council. Again, "Nuts and Bolts" seminars were organized by Deputy President Betsy Lake. A special event "March to Victory" was held with Ambassador Jean Phillips speaking for the Bush-Cheney campaign and Agriculture Commissioner Susan Combs filling in for Senator Kay Bailey Hutchison who had been slated as the speaker. This event along with "Re-Elect Bush" and "Vote" pin sales greatly enriched our treasury. GHC donated over 600 books to Reach Out and Read, participated again in the Dictionary Project, established standing rules for the first time, and coordinated club efforts to donate to Operation Interdependence, a civilian to military delivery system for our troops in Iraq and Afghanistan.

2006-2007 Carolyn Hodges served as president of GHC. "Nuts and Bolts" seminars were held each year as is our tradition. Council hosted Senator John Cornyn at an evening event and Senator Kay Bailey Hutchison spoke at our Immigration Forum in October, 2006. Senate Majority Leader Bill Frist and his wife Karyn also attended. Generous donations were made to the Fisher House on the campus of the VA Hospital and to TFRW for its fundraiser and campaign management school held in Houston. GHC also sponsored a table at the charter ceremony for the Harris County Federation of Black Republicans. A special event celebrating Council's 45th anniversary and kick-off for "Victory '08" is being held today to culminate the activities for these two years.

1988-1989 Kay Shillock was chosen to lead Council. Newly elected presidents received prisms and signature pens from Governor Clements. With the Super Tuesday primary in March, work started early for RW. Awards were given for highest member attendance at precinct conventions the day of the primary. The election season culminated with Houston's George and Barbara Bush becoming President and First Lady. Council made a statement about women's involvement in our political process with the Leadership '89 Seminar, "Women in Politics: Power and Persuasion." Sue Dronberger designed a new logo for GHC at this time.

1990-1991 Betsy Lake was elected president and at the end of her term was elected Harris County RP Chairman. There were 28 clubs in Harris County plus 7 in other counties. Council members attended Legislative Day in Austin and held another Leadership Seminar, "New for the 90's." Penny Butler was elected National Committeewoman and Beverly Kaufman was elected president of TFRW.

1992-1993 Michelle Bain served as Council President. Council celebrated its 30th anniversary lunch honoring past presidents in May, 1992. In August, the Republican National Convention was held in Houston where George Bush and Dan Quayle were re-nominated. Many RW served during the convention in many capacities. There was a tribute to Barbara Bush at the George R. Brown Convention Center. The big blow came when Bill Clinton defeated George Bush, but the former president returned to Houston and a number of RW began to work in his office here. The good thing about this election – Lloyd Bentsen moved from being a U.S. Senator to Secretary of Treasury, and a special election was held to replace him. Voila – our Kay Bailey Hutchison.

1994-1995 Jo Konen was chosen to lead our organization. At this time TFRW President Marcia Saunders asked Council presidents to serve on the TFRW Board as ex officio members. Council members traveled to Austin and heard Governor George W. Bush. Again, Council held a Leadership Seminar and Statewide Candidate Luncheon celebrating Armed Forces Day with over 200 in attendance. In 1995, First Lady Laura Bush's office asked Council to sponsor her first large speaking engagement in Houston. The event was held October 17, 1995, and local clubs were given the opportunity to raise money for their own clubs. Over 500 attended this event.

1996-1997 Serving as president was Barbara Jordan. The Greater Houston Council official pin/jewelry was designed and given to members while another Leadership Seminar was held. An old-fashioned political rally was held at the home of Catherine and Rob Mosbacher in conjunction with the TFRW April Board Meeting hosted by GHC. By 1997, the number of clubs had reached 40 and in September, 1997, GHC sponsored a luncheon featuring Governor George W. Bush where over 1000 were in attendance.

1998-1999 This was an exciting time for GHC with Jan Clark at the helm. The "Republican Women Care" t-shirt was introduced and proved to be a great fundraising item. In September, 1998, the "Victory '98" event made over \$25,000 for GHC. The extremely successful rally and seminar were attended by all statewide and local candidates. The TFRW Convention was held here in Houston, November, 1999, chaired by Barbara Jordan. This was another very successful event!



## Legislative Report

## Republican Runoff Election Information by Bonnie M. Foster

Texas will hold its 2022 runoff elections **May 24** to finalize which Republican primary candidates will be on the ballot in the November general election. In 50 races in the March 1 primary, no candidate exceeded 50% of the vote, bringing about runoff races between the candidates who came in first and second. The winner will face the other major party nominee in that race, as well as possible Libertarian and Green party candidates. Independent and write-in candidates have until the summer to file their candidacies. Listed below are all of the candidates who will be on the ballot in the primary runoffs for statewide, congressional and legislative offices.

Early voting runs from May 16-20. If you voted in a party primary in March, you can vote only in that same party's runoff. Voters who didn't cast a ballot in the primary can vote in either party's runoff.

#### Statewide races

Every Texan voter can cast a ballot in statewide runoff races that include top state officials like the attorney general, lieutenant governor and railroad commissioner. There are four Democratic runoff races and three Republican races.

#### **District-level races**

Texas voters can vote in the U.S. House, State Board of Education, Texas Senate and Texas House runoff races that correspond with the district they live in.

Below is a lightly edited press release issued by Senator Paul Bettencourt (R-Houston) that explains in clear language the benefits of Proposition 1 and Proposition 2. We thought this might be helpful with members who may have questions. — Bonnie Foster

## Public to vote on Senator Bettencourt's Constitutional Amendments Proposition 1 and 2 on May 7, 2022.

The election will be held on Saturday, May 7th, and early voting will begin on Monday, April 25th.

"The Secretary of State has been sending calls to my office about Propositions 1 and 2. Many voters have been finding the ballot language confusing, and I want to clarify what these amendments actually do. Homeowners over the age of 65 will see their freeze values for school taxes actually decline, aka, ISD property tax bills if Proposition 1 passes! Also, if passed, Proposition 2 will lower independent school district property tax bills by increasing the homestead exemption that will save money for the 5.67 million homesteads in the State of Texas," stated Senator Bettencourt.

Below are some plain language talking points to answer many of the frequently asked questions.

#### Proposition 1 will benefit individuals with an over 65 or disabled exemption on their homestead.

- If an individual has an over 65/disabled exemption on their home and this proposition passes, they will receive a reduction on school district property taxes.
- HB 3 from the 86th Legislature compressed school maintenance and operation tax rates across the board except for over 65/disabled because their rate was already lower than the new compressed rate for everyone else.
- This amendment will provide for the same percentage reduction in an individual's school district tax rate that everyone else received in 2019.
- There are 1.8 million over 65 exemptions and 180,000 disabled exemptions, on average these households will see a \$110 reduction the first year and \$125 reduction in the second year; the reduction will continue to grow each year.
- If there is additional school M&O tax rate compression provided by HB 3 in the future, individuals with an over 65/disabled exemption will receive the same percentage tax rate deduction automatically if this amendment passes.

This amendment will become effective as of January 1, 2023, if it passes.

#### Proposition 2 will increase the homestead exemption by \$15,000.

- If this amendment passes the state homestead exemption for school district taxable value purposes will increase from \$25,000 to \$40,000.
- On average, the 5.67 million homesteads in Texas will see a \$175 savings in their school district tax bill at the current average statewide school property tax rate.
- This amendment will be effective as of January 1, 2022, if it passes, so homeowners will see the savings when they receive their property tax bill this fall.

This exemption increase is a permanent and ongoing benefit to homeowners.

If one or both of these amendments passes, no school district will lose any revenue they are entitled to receive from the school funding formulas. State dollars will replace any local dollars that a school district would otherwise lose from the passage of these amendments.

## Conducting Candidate Events – Guide for TFRW Clubs

Editor's Note: In an overheated campaign season we are re-printing the Guide for TFRW clubs for conducting candidate events.

We are also printing the relevant sections of our by-laws concerning candidate endorsements, fairness and causes for removal.

Campaign season presents unique opportunities for clubs. One of those is introducing candidates to the membership. This is done in several ways; you can host a meet and greet, a candidate forum, or possibly a debate.

What's the difference?

A meet and greet is generally an informal event. Candidates are usually introduced and allowed to speak for an allotted period.

A candidate forum is an event typically facilitated by a moderator which includes questions posed to candidates with a set time to respond and possibly rebut.

A debate is a more structured event where questions regarding issues are discussed in greater detail, followed by each participant responding and rebuttals given.

#### **Guidelines for events**

Decide what kind of event you want to host - Remember that TFRW clubs cannot host events for federal candidates; this includes Presidential, Senatorial, and Congressional candidates.

Plan your event, type, location, time structure, and moderator.

When planning time for the event. Start with the total time allotted, calculate how many participants

and how long you will allow for introductions, questions, answers, and wrap-up comments.

Other questions that require consideration are:

- Will the candidates introduce themselves?
- How many minutes are allowed for the introduction?
- Will the candidates be allowed time for a closing statement?
- How many minutes will candidates be allowed to answer questions?
- Are rebuttals allowed? How long? Is there a limit to the number of rebuttals?

#### Remember that:

- All Republican candidates for an office must be invited to attend.
- The invitation to the event should have the guidelines of the forum spelled out.
- Determine in advance if candidates be allowed to display and distribute campaign material.

## Moderator, timer, and questions

The moderator should be someone who can keep things moving and controlled.

A separate person should be the timer to keep time and notify candidates of time left and signal when time runs out. She should be visible to the candidates and will work with the moderator.

### Candidate Events, cont'd.

Some clubs ask for input from members to develop questions to identify areas of interest. If time allows you may solicit questions from the audience.

#### **Table Space Sales**

Some events allow for the sale of table space by candidates to display campaign materials.



Following these simple guidelines will ensure compliance with TFRW rules for candidate events.

**TFRW Bylaws:** 

#### ARTICLE III - POLICY

Section 1. Candidate Endorsement: The President of the Texas Federation of Republican Women, the Vice President – Political Activities, all other currently elected TFRW officers and local federated clubs, their Presidents and Campaign Activities Chairmen shall not publicly endorse any candidate for public office in contested Republican Primaries, Runoff Elections, Special Elections and/or non-partisan elections when more than one Republican is in the race. No candidate shall use the TFRW logo in any political advertising, and any political advertising shall contain the following disclaimer: "This endorsement is given by the individual(s) only, NOT the Texas Federation of Republican Women."

Section 5. Candidate Fairness: After the end of the candidate filing period for any office and ending the day after the final election for that office, it is the policy of TFRW that all Republican candidates for that office shall be treated fairly and equitably. When one Republican candidate for an office is invited to speak at a Federation or local club meeting, then all Republican candidates for that office shall be offered equal presentation time at the same meeting or another meeting before the election.

ARTICLE IV - MEMBERSHIP Section 1. Eligibility:

Section 9. Removal of Local Clubs: The Texas Federation of Republican Women may remove local clubs from membership by two-thirds (2/3) vote of its Executive Committee present and voting. A. Causes for Removal:

7. Publicly endorsing or working for a known candidate of another party in a partisan or non-partisan race where one or more Republicans are in the race, or endorsing a candidate in a contested Republican Primary, runoff or special election by the club, its President or Campaign Activities Chairman. Exception: other than at a regular club meeting, a club is allowed to be involved in a voter education program or forum that concerns a non-partisan election and the candidate's party affiliation is not announced. If the President or Campaign Activities Chairman violates this policy, it shall fall to the local club to remove her from office. Failure to do so will result in the removal of the club from the Federation.
