Greater Houston Council of Federated Republican Women General Meeting Minutes May 16, 2023 Trini Mendenhall Center

- 1. The meeting was called to order at 10:00 AM by President, Tina Gibson.
- 2. Opening Prayer by Immediate Past President Sophia Mafrige.
 - Pledge to the US Flag and Pledge to the State of Texas Flag were by Advisor to President Sherry Peterson.
- 3. President Tina Gibson acknowledged members of the military for Military Recognition Month, also mothers and grandmothers for Mother's Day and graduates. She recognized elected officials and candidates.
- 1st VP Programs SJ Swanson introduced Justice Ken Wise, of the 14th Court of Appeals, who introduced Russell S. Molina, Chairman of the Texas Rangers Bicentennial Celebration and Texas Ranger Chief Tony Leal.

Russell stated details of the history of the Texas Rangers - two hundred years of service.

In 1823, Stephen F. Austin established the Rangers to protect families. Rangers fought and died at the Alamo.

Russell has been working on the Bicentennial for seven years. He is raising funds for a monument to the Rangers in Austin, and he is working on a travel trailer displaying the history of the Texas Rangers.

Chief Leal stated details about the Texas Rangers' operations. The Texas Rangers are a division of the Texas Department of Public Safety. The Rangers conduct major violent crime, public corruption, cold case and officer involved shooting investigations and oversee the department's border security and tactical and crisis negotiation programs. He stated that Texas Rangers are the oldest and finest law enforcement agency.

SJ encouraged Club Presidents to invite Russell Molina to speak to spread the word about the Texas Rangers Bicentennial. The website, TexasRangers2023.gov has details about the Bicentennial.

- 5. 2nd VP Membership Amy Byers called the roll of Member Clubs.
- 6. Recording Secretary Mary Sage stated that minutes of the March 28 meeting were published in the May newsletter. There were no changes. Sophia Mafrige made a motion to approve the minutes as written. Barbara Tague seconded the motion, and the minutes were approved as written.
- 7. Treasurer Micheline Hutson presented the Treasurer's Report as of April 30, 2023.
- 8. President Tina Gibson stated that 135 people attended the Nuts 'N Bolts event on March 28.

She was grateful that so many attended. Tina reported that the TFRW Board voted to hold the 2025 TFRW Convention in San Antonio. The 2023 TFRW Convention will be in Irving. She mentioned TFRW 40 Under 40 that Jenn Knesek is chairing to highlight 40 women under 40 at the convention. The Application form is on the TFRW website. Tina also stated that the Nominating Committee for the GHC 2024 officers will be elected at our September 19 meeting.

Marga Matthews stated that GHC will schedule luncheons for Club Presidents in July.

Corresponding Secretary Elizabeth Lauzon stated that the President's Leadership Handbooks were distributed at the Nuts 'N Bolts event. She mentioned that the current ByLaws are available on a table at this meeting. They were not approved before printing the handbook. She encouraged everyone to take a copy of the current Bylaws. President Gibson thanked Hospitality Chair Edie Holland and the Hospitality Host Clubs: Northwest Forest RW and Memorial West RW.

Treasurer Micheline Hutson said copies of Kellyanne Conway's book are available for \$25 each.

1st VP Programs SJ Swanson stated that Memorial West RW will receive the Membership door prize and a certificate for having seven members attend our meeting. Justice Ken Wise assisted SJ in selecting recipients for three additional door prizes.

- 3. President Tina Gibson recognized elected officials and candidates, and she thanked the Hospitality Host Clubs: Tomball RW and Bay Area RW.
- 4. Recording Secretary Mary Sage stated that minutes of the May 16 meeting were published in the newsletter. There were no changes. A motion was made to approve the minutes as written. The motion was seconded, and the minutes were approved as written.

Legislative Report, Bonnie M. Foster

The Special Session of the Legislature is coming to an end and at the time of this article we do not know if there will be another Special Session. I know the Senate has been working hard on bills. The Senate had a 5 for 5 in a 15-hour double header session back on October 13th. Here is what they are working on and have sent over to the House:

SB1 - adds Education Savings Accounts #ESAs and SB 2 on increasing school funding. Teacher pay raises and increasing the Teacher Incentive Allotment by Education Chairman, Senator Brandon Creighton.

SB4 - which will increase penalties against human smuggling and stash houses, presented by Senator Pete Flores

SB7 - Senator Mayes Middleton is the sponsor prohibiting private employers from requiring employees to get a Covid-19 vaccine.

SB 11 - is creating a new state crime for entering Texas illegally by Chairman, Senator Brian Birdwell.

On the House side they have passed SB4 and SB7. They have passed HB4 which is relating to prohibitions on the illegal entry into or illegal presence in this state by a person who is an alien, the enforcement of those prohibitions, and authorizing under certain circumstances the removal of persons who violate certain of those prohibitions: creating criminal offenses Here is a link for you to follow the status of the Special Session: https://lrl.texas.gov/sessions/specialsessions/index.cfm

I do encourage everyone to get out and vote – either during early voting or on election day. There are some important propositions on the ballot and in each of your counties there are school board and municipality elections as well. Waller County Republican Women



A reminder that 2024 will have many opportunities for members to participate and record your valuable time.


