

Hello everyone,

I am excited to be serving as your Legislative Chair. I hope to provide up-to-date information. I will be sharing two points for the month of March: (1) a roadmap to the State Convention; and (2) the Candidate Resource Committee (CRC) plans.

We want **YOU** to join us at the Republican Party of Texas (RPT) State Convention! The RPT State Convention is where the grassroots start. The Republican Party of Texas Convention will be held in San Antonio on **May 23 – 25, 2024**.

This is where OUR state platform is written, OUR legislative priorities are decided, OUR Republican Executive Committee is elected, and OUR State Chair, Vice Chair, and National Committeeman and Committeewomen are elected. It is vital we have a voice!



Stops on the Way to Convention

STOP 1 - Precinct Convention

Check with local Republican Party. You can introduce and vote on resolutions, then elect delegates and alternates to the next convention level.

STOP 2 - County or Senate District Convention - held on March 23, 2024.

Elect delegates and alternates to the state convention. Delegates will vote on resolutions the committee has worked on that will be used to create the platform.

STOP 3 - State Convention - General Session and Caucus will meet May 23rd – 25th.

Delegates will vote on platform, vote on the rules and vote for the RPT candidates.

Every two years the Republican Party of Texas (RPT) amends its Platform, and it begins at your Precinct Convention with the following process:

- 1. People attending Precinct Conventions will submit a resolution for a vote.
- 2. If passed, the resolution will go to its Senate District Resolution Committee.
- 3. Said Committee will review every resolution, vote on each one, then submit a report with passed resolutions to their Senate District (SD) Convention.
- 4. During the SD Convention, the delegates will amend and vote on the report.
- 5. If the report passes, it will go to the State Platform Committee for review.
- 6. During the State Convention, the committee will amend the 2022 Platform and submit the 2024 Platform.
- 7. The delegates at the State Convention will vote on each plank of the platform.
- 8. If approved, the state party will publish the 2024 State Party Platform on its website.

The Candidate Resource Committee (CRC) of the Republican Party of Texas (RPT) supports down-ballot candidates below state representative. These are local races like county judges, district attorneys, county commissioners, sheriffs, and justices of the peace that directly impact the way we live. These seats also build our bench for future state representatives, state senators, and statewide elected officials. The CRC helps defend Republican strongholds, compete in swing districts, and flip Democrat held seats. All CRC funds are separate from the general RPT funds and go directly to candidates. This year the CRC has entered into a partnership with TFRW to help these worthy down-ballot candidates. Many of these down-ballot candidates are TFRW members who are running for office across the state of Texas. TFRW also has a seat on the committee and will help determine the distribution of funds.

Throwback a Dozen Years - GHC Leading the News About Contested U.S. Senate Seat

Do you remember back in 2012 when the race was on to replace Kay Baily Hutchison's Texas seat in the U.S. Senate? Well, it was the hot topic of conversation around Southeast Texas, and the Greater Houston Council of Federated Republican Women were the ones to listen to on the subject. As this May 2012 Houston Chronicle article reports, the Council conducted a straw poll for the race. Ted Cruz was the candidate receiving the most votes from council members, with then-Texas Lt. Governor David Dewhurst coming in a close second in the poll.

Now-Senator Cruz did eventually win the U.S. Senate seat with the help of the hard work of many Republican Women. As quoted to the Chron, Cruz said then (as he has many times since then), "Republican women are the backbone of our party across Texas. Their hard work has had a powerful impact on races throughout the State for decades, and I am deeply grateful to have their friendship and enthusiastic support."

Here we are today - twelve years later-poised to elect a Republican primary candidate to that U.S. Senate seat, and so many more. And then - so importantly - get to work getting our Republican candidates elected in November. While you look back at this article - also look forward. Be sure to mark your calendars for the GHC Get Out the Vote event on August 27th where we rally for all of Republican candidates across our Council's many counties.

"Republican women are the backbone of our party across Texas. Their hard work has had a powerful impact on races throughout the State for decades, and I am deeply grateful to have their friendship and enthusiastic support," Cruz said. "These decisive straw poll results follow last week's endorsement from the Madison Project ... Momentum continues to build."

Forty-five percent of the representatives of the 40 clubs picked Cruz as their favorite, and Texas Lt. Gov. David Dewhurst came in second with 36.4 percent. (Dewhurst has not yet announced his intentions but is expected to join the race at the conclusion of the Texas Legislature's session.

The residents in the nine counties making up the organization — Brazoria, Chambers, Fort Bend, Galveston, Harris, Jefferson, Montgomery, Waller and Walker — comprise 24.5 percent of the state population, Cruz said.

Texas Railroad Commissioner Elizabeth Ames Jones came in third with 9.1 percent. Texas Railroad Commissioner Michael Williams, former Texas Secretary of State Roger Williams and Rep. Michael McCaul, R-Austin, tied with 3 percent.

GHCFRW General Meeting Minutes

November 14, 2023

- 1. The meeting was called to order at 10:00 AM by President, Tina Gibson.
- 2. The Presentation of Colors was by the All Glory Honor Guard and Primary Colors Guard by the Jr. ROTC of E. L. Furr High School.
- Opening Prayer by President Tina Gibson.
 Pledge to the US Flag by U.S. Army Veteran Dani Post and Pledge to the State of Texas Flag by U.S. Army Veteran Tim Stroud.
- 4. 1st VP SJ Swanson said she was grateful to have two Color Guards for today's Veterans Day Salute. She read the history of Veterans Day and said that County Chair Liaison Emely McHattie would present a Veterans Day Salute with Anthems of the Army, Marine Corps, Navy, Air Force and Coast Guard. SJ asked all Veterans to stand and state their name, branch of service and their role in the military. Each Veteran was presented an American flag.
- 5. President Tina Gibson recognized elected officials and candidates.
- 6. 1st VP Programs SJ Swanson introduced Debra Coffey, who served as TFRW First VP and as a Precinct Chair. Debra had a very memorable video presentation about her Dad, Captain Robert Russell "Bear" Barnett, USAF, who was born in 1933 and graduated with a BA from Baylor University. He served in Vietnam and Laos and was shot down and crashed into a mountain on April 7, 1966, when Debra and her sister were 11 and 9. Her Dad was declared killed in action, non-recovered. The U.S. Defense POW/MIA Accounting Agency used circumstantial evidence and dental comparisons, which matched his records. Her Dad's remains were repatriated on April 6, 2017, 50 years after being shot down. Debra said that Carolyn Hodges is on the Board of the Texas State Cemetery, and Carolyn facilitated having Capt. Barnett buried in the Texas State Cemetery in Austin. Debra presented a beautiful video of the life of her Dad, Robert Russell "Bear" Barnett. There wasn't a dry eye in the room!
- 7. 2nd VP Membership Amy Byers was absent. Ronnye Cowell called the Roll Call of member clubs and recorded the number of members attending from each club.
- 8. Recording Secretary Mary Sage stated that minutes of the September 19 meeting were published in the newsletter. There were no changes. Immediate Past President Sopha Mafrige made a motion to approve the minutes as written. Bylaws Chair Deb Cupples seconded the motion, and the September 19 minutes were approved as written.
- 9. Treasurer Micheline Hutson was absent. Tina presented the Treasurer's Report as of October 31, 2023.
- 10. President Gibson reported that many of our members attended the TFRW Convention.
- 11. 1st VP Programs stated that David Maulsby, Director of Camp Hope that provides 120-bed housing for veterans with PTSD, was unable to attend our meeting. Rose Escorcia represented Maggie Peterson, who founded Camp Shield. SJ asked members to give gift cards or cash that we will donate to Camp Shield and Camp Hope.
- 12. Campaign Activities Chair Gayla Baker stated that three-fourths of our Clubs earned Awards at the TFRW Convention. Golden Triangle RW and Cy Fair RW were recognized with awards for campaign hours at the convention.
- President Gibson stated that West Pearland RW provided a beautiful red, white and blue cake and Clear Creek RW brought refreshments for our meeting.
- 14. Recording Secretary Mary Sage presented a Mini Nuts N' Bolts minute providing details about the office of the Recording Secretary. She read the GHC Bylaws description for the Recording Secretary, who keeps the history of our organization, mentioned some of her experiences serving in that office, and said she is honored to have served with Presidents Sophia Mafrige and Tina Gibson.

15. President Tina Gibson said we would have the election of our 2024-2025 officers. Tina said the Nominating Committee report was published in the Newsletter. She has not been notified of a nomination from the floor. Tina asked Ronnye Cowell to read the Nominating Committee report. The Nominating Committee members were Amy Byers (Chair), Ronnye Cowell, Jenn Knesek, Marga Matthews and SJ Swanson. The following members have agreed to serve as 2024-2025 GHC officers. Ronnye asked members to stand.



Camp Hope opened in 2012 with the mission to relieve the effects of combat and trauma on male veterans, suffering with PTSD, and their family members. There is no cost for participants.

David Maulsby is the Executive Director for Camp Hope. Beginning in 2009, Mr. Maulsby began the mission of the PTSD Foundation of America by walking the streets of Houston, finding homeless vets. He is an ordained minister, bringing his strong faith and steady leadership to serve and support our country's veterans and their families. His message centers on what Camp Hope is accomplishing and how the involvement of NWFRW makes a difference.



Camp SHiEld serves women veterans. The number of women veterans in our nation is currently around 2 million-an all time high and a number that continues to grow. Camp SHiEld is a resource created BY women veterans FOR women veterans and addresses the emotional, social and physical wounds. 


